Effective with deliveries made after October 1, 2018, the cost of all liquid bleach products will increase by six percent (6%) for all packaged sizes.

These increases are due to the escalating costs of the chlor alkali industry driving both Caustic Soda and Chlorine pricing at the same time. Coupled with increases in the local labor, fuel, transportation, and packaging costs, we have no option but to increase pricing.

Although these cost increases are beyond our control, please be assured that your chemical needs will be met.

Please find enclosed a copy of your new Tolco Corporation negotiated pricing.

It has been a long-standing policy of ours to honor our contract pricing for 12 months. We appreciate and value your business and understand that your customers, at times, require you to guarantee pricing. That is why we have always done our best to hold your pricing. Over the course of those 12 months, we absorb price increases, freight increases, surcharges, changes in labor rates, etc.

This last year has proven more challenging as we have seen significant increases on several fronts Specifically, Tolco has incurred the following increases that have affected our costs of goods:

Transportation: 5% increase Truck load rates: 55% increase Corrugated and Paper: 8% increase Imprinting Supplies: 10% increase Steel and plastics: 5-10% increase

In addition, we have seen significant increases in our domestic and foreign labor rates as well as significant fluctuations in foreign currency values.

The attached pricing reflects your updated costs and we will do everything we can to hold the costs for another 12 months.

Still we have done what we can to absorb as much of the cost as possible and minimize the effect on you can reduced outcomes.

We are notifying you that as of October 1, 2018, Disco Inc. will be increasing prices on all products. As most of you are aware, freight and raw materials have been experiencing significant inflation over the past several months. Contributing to the increase in freight are new federal and state regulations and lack of drivers. Our raw material suppliers have pushed through some of the highest price increases we have seen in many years. Due to all of these factors, we are implementing a 7% increase on all items. Specific categories, such as, soap pads and powdered cleaners will have a more significant increase.

This increase will take effect on all orders placed on or after October 1, 2018. Orders received by 5:00 PM EST on September 30, 2018 calling for immediate shipment will be invoiced at current prices. Orders will be limited to normal buying patterns.

Dear Valued Customer,

At RB we committed to create significant category growth for our commercial partners in 2018 and we are delivering on our commitment beyond the average market in our categories.

This has been possible thanks to your partnership, the launch of successful innovative new products and RB's increased investment with commercial consumers and shoppers, however significant inflation in commodities between 12-33% and supply costs between 3-7% are negatively impacting our strategic intent to continuously improve our products and provide better value to our consumers, therefore Reckitt Benckiser Hygiene Home & our Professional Divisions find it necessary to implement price increases between 4.2% - 10% on a select number of product lines.

This is to advise that Reckitt Benckiser Hygiene Home Division will increase prices on select product lines in two waves, one wave is effective October 1", 2018 and the other February 1", 2019. Details for October 1" are attached and details for February 1" will be shared no later than September 1".

Please be reassured that RB will continue to aggressively pursue cost savings initiatives to balance commodity cost increases and at the same time we will continue to invest in innovation and the improved quality of our products for the benefit of our customers and consumers.
